The council are content to leave a final decision to SC but have concerns regarding potential increase in the width of road and use by large tractors which may have an effect on the public right of way and local ecology. We were also concerned about the quality of submission that did not indicate in enough detail where the trees were to be cut back and cut down. There was also no mention made of replanting trees felled.
