P50.15 **MATTERS ARISING** – The Clerk advised councillors that the Inquiry into the refusal of planning application 14/05324/OUT to develop land off Gorse Lane would begin on 26 January 2016 and was expected to take up to 4 days. She also provided some information from a resident that gave a breakdown of the areas of disagreement from the appellant.

It was also discussed about getting in contact with CPRE to seek their advice on the upcoming inquiry.

The Clerk also informed the Committee of Cllr Ball's resignation from the Parish Council and his role as the Chair of the Planning Committee, he is planning to stay until the end of the year. The Clerk suggested holding a re-election of the Chair at the next Planning Committee meeting.

Following discussion the Clerk was asked to check if the results of the inquiry, if they go in Bayston Hill's favour, would be extant in perpetuity or can it be rescinded at some time in the future should the 5 year housing land supply go under the required amount again. **Action: Clerk.** 

Further discussion ensued about the use of specialist advice if Shropshire Council are unable to answer our question, the fact that the condition of the Parish Plan is not helpful for planning, the various types of training available and the Clerk to inform residents about the inquiry via her Villager article. **Action: Clerk.**
