Chairman's Report

I am very proud to have been elected Chairman of Bayston Hill Parish Council at our Annual Council Meeting in May 2009. I am very grateful to my fellow councillors for their commitment to the needs of the village and for their continued support. The role of being a councillor for one of the county's biggest parishes no longer consists of attending a few meetings, but is now expected to attend regular training, abide by new legislation issues and to read large amounts of information.

Unfortunately, we have lost some hardworking councillors for various personal reasons. I would like to thank Michael Harrop, Chris Hitchcock, Jason Manley, John Crick, Alan Reynolds and Noel Oakley on behalf of the village for all their hard work while they served on the council. We welcome James Hindson who joined us in January. Our Young Councillor, Rose Moore, on reaching the age of 19 had to leave, but applied and when a vacancy arose was co-opted onto the council. We have two Young Councillors, Sian Thomas and Lucy Johnston-Squire who joined us with enthusiasm. We have three vacancies and if anyone is interested, please contact the Parish Clerk for an information pack.

During the summer Daniel Kawczynski MP visited the village and was very impressed with the recreational and leisure facilities available to parishioner.

Bayston Hill Local Joint Committee

Our very first Bayston Hill Local Joint Committee took place in the Memorial Hall in July 2009 and three others have followed. This committee comprises of three Shropshire Councillors and 3 Parish Councillors. We are pleased to announce that word is spreading around the village and more residents are attending these very important and informative meetings. Following the Parish Plan launched in June 2006 most of the action points have been addressed by the Parish Council and it was therefore felt that the Local Joint Committee would take on the task of asking what else the residents would like for the village and a questionnaire sent out to all the households and the results were published at the meeting in March 2010. The next quarterly meetings are scheduled for: 27 May, 15 July, 21 October 2010 and 3 February 2011.

Training

During the year the Shropshire Association of Local Councils held training sessions for Shropshire Town and Parish Council members. Members of Bayston Hill attended these sessions and received training on various subjects such as, Budget and Precept Setting, Powers and Functions, Planning, Finance, The Power of Wellbeing.

These training and presentation sessions continue throughout the year and councillors and the Clerk are always encouraged to attend.

Parish Achievements 2009-2010

Parish Quality Status - The Parish Council's main achievement was gaining Parish Quality Status. This involved a lot of hard work by our Clerk over a period of 12 months. The Clerk and I were presented with the certificate at the Shropshire Association of Local Councils at their AGM in December and our certificate is proudly displayed in the Parish Office.

The Power of Well-being – After passing the module 7 CiLCA course the Clerk was presented with the certificate for The Power of Well-being.

Lythwood Sports Pavilion - The Parish Council others achievements this year included the complete upgrade of our Lythwood Pavilion to comply with the Disability Discrimination Act. We now have a disabled shower room and toilet facility, a meeting room and new kitchen area. The outside open terrace facing the Bowling Green has been partially enclosed with a ramp into the building and there are two disabled parking spaces available close to the entrance to the Pavilion.

Astro Turf Pitch - The height of the Astro Turf fence has been raised to prevent the footballs going over the fence into the hedge. The teams consider this to be a big improvement to the facility.

Community Woodland – The Community Woodland has now a new all-ability path suitable for wheelchairs, prams and pushchairs. There are also benches for people to rest and take in the view.

These have been provided through an Access Improvement project funded by the Aggregates Levy Sustainability Fund, Parish Council and Shropshire Council's Shropshire Outdoors project. This project has also supplied new access gates which will allow anyone with a disability to park a car providing they have a RADAR key. These keys can be obtained from Shirehall, Guildhall and the Lantern and they are also available on loan from the Parish Office.

We have again won the Award as runners up for the Jan Snell Parish Achievements this year.

Crime and Policing

This year we have one Local Police Officer, Ray Foster and Community Support Officers, Lyn Birch and Mark Barnes, patrolling the village. If you have any concerns please contact them at Shrewsbury Police Station (Tel: 0300 333 3000). They are willing to help and assist.
