Minutes of the Full Council Meeting held at 7.00 pm on **Monday 19 October 2020** via Zoom Video Conferencing.

67.20/21 TO RECEIVE APOLOGIES AND REASONS FOR ABSENCE – None

68.20/21 **DECLARATIONS OF INTEREST** – Cllr Whittall declared her interest in

the football pitches, which are hired by her son-in-law.

69.20/21 **PUBLIC SPEAKING/QUESTIONS AT COUNCIL MEETINGS** – There were

no members of the public present.

70.20/21 SHROPSHIRE CLIMATE ACTION PARTNERSHIP – Allan Wilson – Chair

of the Steering Group (Vice-Chair SALC) gave an interesting presentation on the make up and work of SCAP. It is an umbrella organisation taking in long established groups based throughout Shropshire. AW referenced <u>zerocarbonshropshire.org</u> for further background. It is council business by virtue of the Climate Change Act 2008, amended 27th June 2019, setting the target of "net zero" carbon emissions by 2050. The intention is for the UK to play its part in limiting the global rise in temperature to 1.5°C. A copy of the presentation slides will be available for distribution to members. Because of connection issues, TC may have missed some

parts of the presentation.

71.20/21 CHAIR'S REPORT – MU & TC met with a resident of BH who has a keen

interest in encouraging nature in the village, particularly hedgehogs. It was agreed that they will put together a proposal on what steps could be taken. Also, a request for the council to support a grant application. MU agreed to review both and council can decide on the way to move forward. MU attended a Shropshire Association of Local Councils (SALC) webinar on Developing a Communications Strategy. MU accepts we already have a policy in place but there could be some benefit in an overall review, potentially once we have more member seats occupied. MU will put together a summary from the notes he took. MU finally ends his report

with a request that council formally thanks Tarmac for their kind gesture in supplying 10 tonnes of 40mm scalpings to allow us to undertake some path repair/maintenance work across the piece. **SJ to action.**

- 72.20/21 SHROPSHIRE COUNCILLOR'S REPORT Cllr Ted Clarke has little to report since the last council meeting. A minor matter of the tree adjacent to the library (on the other side of the road) has recently been lopped/reduced. Also the long awaited repair/replacement of some street signage in the village may be seeing some action.
- 73.20/21 MINUTES The draft minutes for the Council Meeting held Monday 28th September 2020 are now put to the Council as an accurate record of proceedings. The motion proposed AP and seconded FJ was passed unanimously.
- POSITIONING PAPER CARBON NEUTRAL BY 2035 Just picking up on a point from the presentation by Allan MU notes that Shropshire Council (SC) have a target of being carbon neutral by 2030. There is an argument that maybe BHPC should review their target date of 2035 and possibly align with SC. Mu referenced his published positioning paper. MU looked for feedback from members that can be presented back at a future full council meeting. All members agreed. Finally, MU has had a brief discussion with one of the council's preferred suppliers over an energy audit of our buildings. This could feed into plans on how to reduce the CO2 emissions by our activities.
- 75.20/21 TREE REGENERATION / NEW PLANTING - MU thanks JW for running with this item. The recent offer of trees to plant was oversubscribed but we can prepare for the next offer, understood to be March 2021 – a good time to plant. JW asked members to all consider where new trees could be planted in BH, primarily in locations the council manages, and report back. MU suggests that SJ and JW review the land assets of BHPC to scope the opportunity to identify planting locations. He also sees this as a rolling planting programme over a number of years, and could include inviting residents to plant a tree too (on land they own). AP made reference to a recent Tree Council email offer of a pack of 25 fruit trees/hedgerow plants (1.5m in height). He thought the Sensory Gardens could be a suitable planting location. AP to forward the email offer in question. TC suggests a general "tree condition" inspection be undertaken. SJ to review what BHPC have done in the past and bring forward recommendation(s). Also mentioned was the involvement of the Forestry Commission who do have grant schemes too..

- 80.20/21 **EXCLUSION OF THE PRESS AND PUBLIC -** Motion **proposed AP**, **seconded JW** It was **unanimously resolved** to exclude the press and public under the Public Bodies (Admission to Meetings) Act 1960 in order to allow the Council to discuss confidential matters.
