GRANT APPLICATION

Each year the Parish Council has a small budget allocation available to give as grants to local organisations to help improve the well being of Bayston Hill residents.

Please use the guidance below to confirm your eligibility for a grant.

About you

- you can apply as an individual or an organisation
- you must live or work in the Parish of Bayston Hill or be very closely associated with the Parish.

Your idea for a grant must

- improve the well being of people in Bayston Hill
- support an aspect of the Bayston Hill Parish Plan. Copies of the Parish Plan are available from the Parish Office, the Library and can be downloaded from the web site.

Your application should be

- for a small sum of money a maximum of £500.
- if possible, have some matching funding of between 25%-50%.
- for something that it might be difficult to find funding for from somewhere else

Help with your application

If you are thinking of making an application, please contact the Parish Clerk. If you do not meet all the criteria listed above it might still be possible to apply for a grant.

Number of grants to be awarded

The Council is hoping to award between three and six grants each year, subject to the limits of the fund.

When you have finished your project

We shall expect you to spend the grant within 12 months and submit a short report and statement of accounts. The Parish Clerk will explain the format of the report and accounts to you.

This group was established to celebrate the late Queens Jubilee organising a Parade, Fete and Community Games events. As the number of volunteers reduced considerably the group changes its focus to provide a unique event for Villagers at Christmas hence Jingelation was conceived!

We always aim to keep our event inclusive and where there are costs - to keep them very low. Pre Covid 19 we provided a Father Christmas gifting opportunity sourcing gifts; tickets only covered those costs. So, not as a money-making event, we rely only on grants, donations and whatever is raised with raffles and refreshments. The Christmas lit walk through, has always been free for all who want to attend.

This year we have decided that in the financial situation and being very short of volunteers, we are yet again not charging but equally we are not running a gifting experience, raffle or refreshments.

We are a group made of Bayston Hill volunteers for Villagers and their families.

There are eight active members of this group. We expect that over 400 will attend the event on the evening of Saturday 17th December 4 -7.30pm.

THE REASON FOR YOUR GRANT APPLICATION

9. Explain why you need a grant, who will benefit from it and how.

Last year, our first return after Covid, we ran a similar event as we will this year; no charges, no raffle and no refreshments. From last year's event we gained donations which we have now spent on replacement lights, due to aged items and breakages; for safety reasons we needed to purchase extension leads, no longer relying on using members personal equipment.

This year our insurance, a one-day event coverage is almost a third more expensive currently coming up as £160 approx.

Now we have little left in the pot!

The money we are requesting will allow us to buy new lights and larger stand-alone items, these are very popular and we are aware that to always look different and fresh is the attraction.

We respectfully request £500. From this point in our budget any funds we gain in advance of the event, will all be spent on lighting and lighting effects trying to make enhanced scenes rather than random items which is often the effect our small amounts can be seen.
